FIRST AID IN THE WORKPLACE REGULATORY OVERVIEW



MANDATORY LEGAL REQUIREMENT

WORK HEALTH & SAFETY ACT

The WHS ACT is a legislative document that provides a balanced and nationally consistent framework to secure the health and safety of workers and workplaces. Penalties may apply if workplaces are found not following the WHS ACT or Regulations.

MANDATORY LEGAL REQUIREMENT

WORK HEALTH & SAFETY REGULATIONS

The WHS Regulation is a legislative instrument that varies according to time, place or circumstance. The regulations outline health and safety requirements for duty holders by environment, operation and duty/task being carried out.

FIRST AID IN THE WORKPLACE CODE OF PRACTICE

The Code of Practice provides PRACTICAL GUIDANCE for persons conducting a business or undertaking on how to comply with duties under the WHS Act and Regulations to provide adequate first aid facilities in the workplace. It includes information on first aid kits, procedures, facilities and training for first aiders.

EVERY WORKPLACE REQUIRES FIRST AID KITS

WORKPLACE FIRST AID KITS GUIDELINE:

HIGH RISK WORKPLACE

EXAMPLE: Construction, Warehousing, Manufacturing, Laboratories

DEFINITION: A workplace where workers are exposed to hazards that could result in serious injury or illness and would require first aid

RECOMMENDATION: 1 first aid kit should be provided on site for at least every 25 workers

LOW RISK WORKPLACE

EXAMPLE: Office Buildings, Home Offices, Retail Shop, Cars and Trucks

DEFINITION: A workplace where workers are less likely to be exposed to hazards that could result in serious injury or illness

RECOMMENDATION: 1 first aid kit should be provided on site for at least every 50 workers

FIRST AID ROOM REFERENCE LIST

- ✓ **Be located within easy access to a sink with hot and cold water (where this is not provided in the room)**
- ✓ **Offer privacy via screening or a door**
- ✓ **Be easily accessible to emergency services (minimum door width of 1m for stretcher access)**
- ✓ **Be well lit and ventilated**
- ✓ **Have an appropriate floor area (14m² as a guide)**
- ✓ **Have an entrance that is clearly marked with first aid signage**

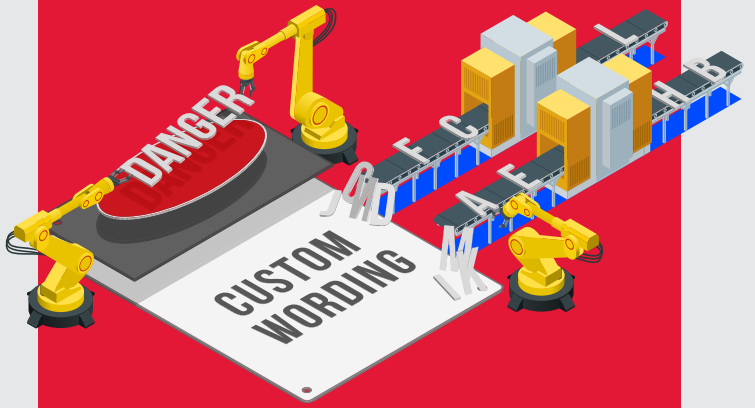

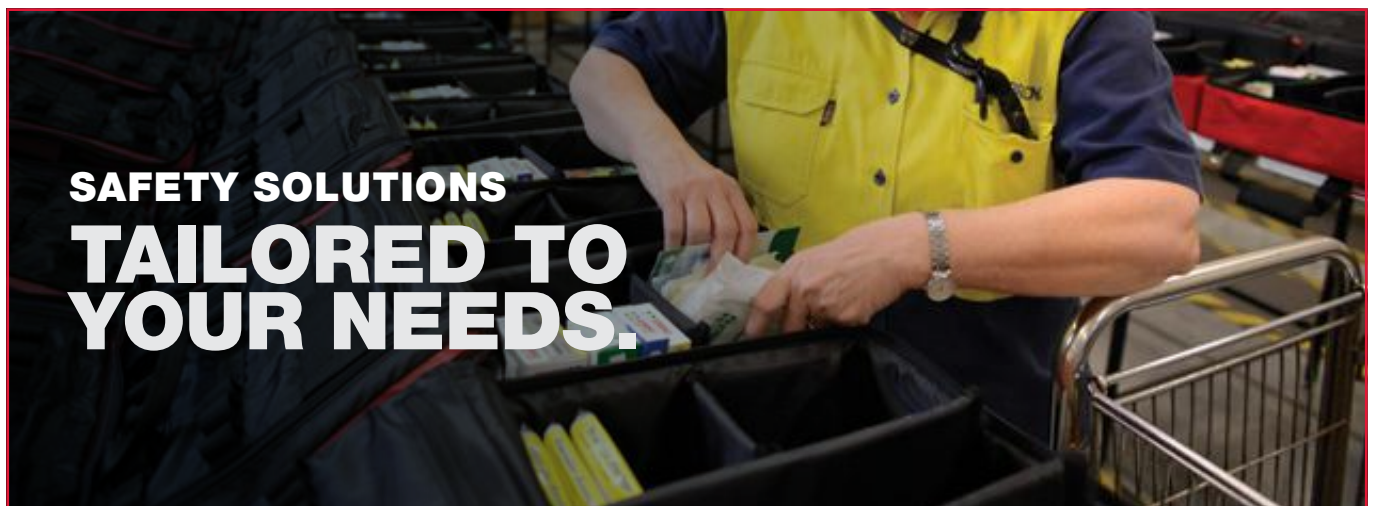
